 - (6) Highway Superintendent: Not present.

- (8) County Legislature: Mark Rondinaro updated us on the latest sales tax figures, which are up significantly from this same time last year.

There was also some open discussion on unfunded mandates and how they are, or not, distributed between the State and Counties.

(9) Lakes Association: Cartha Conklin reported that they only have two meeting left for this season. (Sept. 16th and Oct. 21st both at 10:00 am at the Tyrone Town Hall.

She also added that they are still waiting to hear from the Adirondack Plant survey for the results of this year's lake treatments to see what needs to be done next year.

Mark Rondinaro announced that the Republican Committee dinner will be held on October 14th @ 5:30 pm. at Logan Ridge Winery. Tickets are \$50 for one and \$80 for two. You can contact the Schulyer County Republican Committee for purchase.
