**RE: ADOPT LOCAL LAW NO. 1 OF THE YEAR 2024 – A LOCAL LAW TO
OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL
MUNICIPAL LAW 3-c**

WHEREAS, due to the fact the Humane Society of Schuyler County has raise their cost of sheltering the towns stray dogs from approximately \$1,000.00 per year to \$16,385.00. The cost of employee wages and benefits without raising taxes over the limit for the last 10 years, The loss of Mortgage tax revenue by approximately \$34,000, it will be extremely difficult to keep the 2025 budget within the 2% cap limit, and

WHEREAS, it is necessary to pass a local law in order to increase the tax levy more than the 2%, prior to the 2025 budget being adopted, and

WHEREAS, Local Law No. 1 of the year 2024 was introduced at the September 10, 2024 meeting, with a Public Hearing scheduled for the October 08, 2024 meeting, said Public Hearing having been duly held.

NOW, THEREFORE, BE IT RESOLVED, that Local Law No. 1 of the year 2024, as attached hereto be adopted as attached, and

BE IT FURTHER RESOLVED, that the Town Clerk is hereby directed to file said Local Law with the Secretary of State.

RE: AUTHORIZATION TO REQUEST LOWER SPEED LIMIT ON COUNTY ROAD 25

WHEREAS, County Rd 25., is a County Road located in the Town of Tyrone; and

WHEREAS, County Rd 25, the current speed limit of 55 represents a constant danger to the 137 residents along this densely populated stretch with many homesites, parking and play areas and uphill/obstructed view driveways located within feet of the road. In addition, particularly during the summer months, this road, with its narrow shoulders, is the only east lakeside thoroughfare for bikers, runners and walkers. Finally, the road includes a mobile home park that contains 27 trailers and there are at least 7 other properties that have structures closely situated on both sides of the road, and

WHEREAS, the Tyrone Town Board and The Highway Superintendent are in support of lowering the maximum speed limit on West Lake Rd. to 35 mph; and

NOW, THEREFORE, BE IT RESOLVED, under Section 1622.1 of the Vehicle and Traffic Law, the Town of Tyrone requests that NYSDOT establish a lower speed limit of 35 mph on West Lake Rd., from Scout Hill Rd. (the Boy Scout Camp) to the end of the road at State Route 230 (Approximately 2 miles) , and

NOW, THEREFORE, BE IT RESOLVED, that the Town of Tyrone Highway Superintendent will Submit a Form TE9 as well as this resolution to the NYSDOT for their approval.
